Terms & Conditions

APPLICATION

- This Application and any required documentation must be filled out completely, truthfully and accurately. Customers are advised to retain a copy of this Application and any accompanying documentation submitted to DTE Energy under this program. DTE Energy will not be responsible for lost documentation pertaining to this application request. This application is effective and valid from June 1 through December 31, 2010.
- Details of this program, including incentive levels, are subject to change or cancellation without prior notice. This Application and supporting documentation must be received within 45 days of survey/audit completion or 45 days of weatherization installation.
- All materials must be purchased and installed prior to application submission.
- Auditor bonuses for the auditors or homeowner receiving rebate Level 2 or 3 Audits are \$150 (\$75 after initial energy audit/\$75 after customer installs at least one qualified measure). In order to participate, auditors must be BPI, RESNet or NEAT certified within the current program year.
- Household total rebates are \$1,350 or \$500 depending on if an energy audit was performed.

ELIGIBILITY

- MichCon must be your primary heating fuel supplier, or you must have all electric heat with Detroit Edison.
- Individual qualified measures have installation requirements in order to receive rebate. See DTE Energy rebate chart for each measure minimum requirements, including quantity, area/size, and material specifications.
- Energy Audit Rebates are only available to site-built residential homes or detached condominiums. Mobile homes, manufacturing homes, connected condominiums, townhouses and other types of multi-family buildings are not eligible for energy audit rebates. They are however, eligible for certain weatherization rebates.
- Weatherization rebates are only available to site-built residential homes, detached condominiums, or single family condominiums with less than 4 living units per building.

INFORMATION RELEASE

- Customer agrees that DTE Energy may include customer's name, address, DTE Energy account number, DTE Energy services and resulting energy savings ("information") in a database hosted by a contractor of DTE energy and such information may be included in reports or other documentation submitted to DTE Energy, and/or the Michigan Public Service Commission ("Reports"). DTE Energy will treat such information as confidential and the information in the Reports shall only be in the aggregate.

LIMITED FUNDS

- The program has a limited budget, but is a multi-year program. Applications will be processed until allocated funds are spent each program year. DTE Energy reserves the right not to pay the incentive if funds are not available at the time of the Application approval, or if the form and all required additional information are not filled out completely and accurately.

PAYMENT

- Please allow up to 6-8 weeks for payment. Payment processing may take longer if information is incomplete or inaccurate.
